In dieses Literaturverzeichnis wurden Monographien, Aufsatzsammlungen und wichtige Zeitschriftenaufsätze aufgenommen, die entweder explizit die britische Krise/Krankheit zum Thema haben oder es sich zum Ziel setzen, entscheidende und langfristig bedeutungsvolle Veränderungen im politischen, sozialen oder wirtschaftlichen System Großbritanniens zu behandeln. Dabei wurden vor allem Arbeiten berücksichtigt, die die Entwicklungen der letzten Jahrzehnte analysieren und von daher nicht in erster Linie an der Aufarbeitung der englischen Geschichte interessiert sind.

Bei der Erstellung des Verzeichnisses wurden die Rezensionsteile der wichtigsten englisch- und deutschsprachigen politikwissenschaftlichen Zeitschriften verwandt (Political Studies, Political Quarterly, Parliamentary Affairs, Government and Opposition, The Economist, Politische Vierteljahresschrift, Zeitschrift für Parlamentsfragen), sowie die British National Bibliography und - zurückgehend bis 1981 - die British Book News.
